#### **About the Role**

This position will provide strategic leadership and technical guidance for landscape restoration across the state. The role focuses on policy analysis, convergence of government schemes, scaling innovative financial mechanisms, and supporting districts in successful restoration-linked economic transformation.





### Responsibilities

- Lead strategy planning and policy integration by preparing the State Landscape Restoration Strategy and Roadmap, conducting policy analysis for integration into state development plans, and advising state departments on restoration-linked policy design and incentives.
- Drive convergence and inter-departmental coordination by integrating restoration planning across departments like Forests, Agriculture, and Rural Development, and building frameworks to dovetail resources from government schemes and external funding sources.
- Foster capacity development and knowledge management by building district team capacities, commissioning studies and knowledge products, developing state-level monitoring systems, and disseminating best practices to create replicable models.







- Develop innovative financial mechanisms by designing and piloting financing models for restoration, such as payment for ecosystem services and carbon finance, and facilitate private sector participation in market-based restoration opportunities.
- Provide oversight, monitoring, and learning by reviewing district-level plans, establishing impact monitoring systems, and providing technical inputs and policy recommendations to inform state and central-level decision-making.
- Promote restoration-linked livelihoods and enterprises by scaling up agroforestry, sustainable
  agriculture, and community forestry, and enable partnerships with producer collectives and
  market actors for benefit-sharing.

#### **Knowledge and Skills**

- Strong understanding of government structures and processes, with the ability to facilitate timely approvals and communications
- Experience in managing and delivering mitigation and restoration projects
- Capability to build and maintain networks across institutions and organizations, particularly in Central India
- Multi-lingual with experience working in diverse cultural contexts
- Sound knowledge of carbon sequestration science and carbon markets

#### **Qualifications & Experiences**

- Post-graduate degree in a field related to forestry, natural resource management, ecology or another related field of study with 3-5 years of experience relevant to this position
- Experience with the management of large projects in the conservation/forestry/natural resource management sector
- Experience understanding of topics related to forests, conservation and people
- Experience understanding of the principles and practice of integrated landscape approaches to restoration (i.e., both within and outside forests)
- Good communication skills, both verbal and writing skills is required
