Stakeholder Influencing	Ability to effectively influence stakeholders through data-driven insights, strategic thinking, and relationship-building. This includes identifying and organizing data sources to inform policy implementation, understanding complex challenges and intersectional spaces, and developing trusting relationships with key government counterparts and stakeholders. Additionally, this involves proactive project management, ensuring deliverables align with strategic goals, and demonstrating thematic knowledge to identify opportunities for aligning government programs with organizational intent, ultimately driving impact in focus states and districts.
People Engagement	Strong people engagement skills through teamwork, leadership, and effective communication. This includes being a positive team member who respects and values colleagues' contributions, providing support beyond immediate unit, and setting bold objectives to drive ambitious goals. Effective communication skills enable persuasive verbal and written interactions, organizing and structuring information in a clear and compelling manner.
Institution Development	Commitment to institutional development through fostering a culture of excellence, adaptability, and learning, while driving resource mobilization efforts to bring in investments and talent, and positioning TRI's value proposition within key networks and stakeholder groups to enhance the organization's reputation and impact.
Key responsibilities to bring PPiA efforts to fruition, while indicative and not exhaustive include:	 Conduct participatory assessments in focus blocks to map water resources, soil profiles, and solar viability, aligning with PPiA's community-state synergy model Develop project plans, including site-specific solar lift irrigation designs, cost estimates, and scalability strategies for 50-100 blocks Facilitate consultations with JSLPS teams, PRIs, women's SHGs, and MNRE vendors to co-create equitable implementation strategies. Incorporate market linkages and administrative protocols per PPiA guidelines. Oversee installation of solar lift irrigation systems, procurement, and community training (e.g., WUG maintenance) Coordinate with district officials, block officials of JSLPS, and MoRD/MNRE for timely execution, targeting 95% system uptime and 500+ farmers/block Manage partnerships for funding and convergence with schemes like PM-KUSUM. Resolve implementation issues in collaboration with community Institutions and local PRIs, using PPiA's adaptive management approach.

- Deploy monitoring tools (e.g., GIS dashboards) to track irrigation efficiency, yield gains, and carbon reduction
- Submit quarterly reports to JSLPS leadership, highlighting PPiA impacts on governance and equity.
- Conduct impact evaluations with external agencies, targeting 50% women beneficiaries.
- Participate in cross-state PPiA learning exchanges with Uttar Pradesh, Madhya Pradesh, etc
- Train block teams and communities on solar technology and policy advocacy
- Represent JSLPS in inter-ministerial forums to advocate for policy integration
