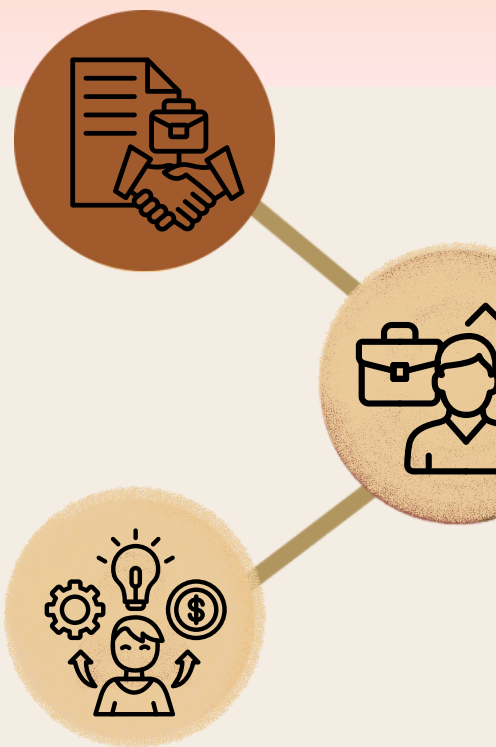
About the Role

- Drive promotion of women and youth-led nano and mini enterprises in rural areas.
- Lead identification and development of green and sustainable value chains for rural industrialisation
- Design and operationalise programs, guidelines, and SoPs related to rural industrialisation.
- Draft and operationalise State CSR policy, frameworks, and Ease of Doing CSR mechanisms in the state
- Coordinate with districts, line departments, corporates, and partner institutions for promotion of rural industrialisation in Chhattisgarh
- Prepare policy notes, reports, presentations, and progress updates on enterprise and entrepreneurship promotion
- Organise and manage meetings, workshops, consultations, and review processes related to enterprise and entrepreneurship promotion in the State
